# 5. To receive an update from Wakefield District Council relating to the complaint lodge regarding High Ackworth traffic calming measures reviewed by this committee and make recommendation.

**5.1** The Wakefield District Council complaint response had previously been circulated to the committee members. The letter stated that the red road markings would be repainted once the recurrent drainage problem on Pontefract Rd had been addressed by September 2025.

The committee recommended that photographs and a map are gained from Wakefield District Council to ensure the area in question has been accounted for within the planned works.

### 6. To receive from Cllr Roberts a draft tree policy for review by this committee.

**6.1** The draft policy was reviewed. It was noted the effort that Cllr Roberts had gone to in creating the new draft policy.

It was proposed that a cover-all 'Environmental Policy' may be a better option for the parish council that would encompass trees, planning and climate.

The committee recommended that an 'Environmental Policy' is drafted by Cllr Roberts and the Clerk and brought back to a later meeting.

### 7. To receive correspondence from a resident and make recommendation.

7.1 A request had been submitted regarding gaining updates on proposed planning in Ackworth.

The Clerk advised that all planning applications are listed on the Council Meeting agenda.

The committee made the following recommendations:

- That Cllr A Sherratt would write a statement in relation to SHLAA for the council website which would include the link for Wakefield District Council planning applications.
- That the Clerk would contact the school to invite them to future meetings to provide any community updates on land sale.
- That the Clerk would send the resident information on where the Council agendas and meeting minutes can be found on the website.

#### 8. CIL Referred Item

**8.1** To review conditions over public pathway footbridges across the village and make recommendation

**8.1** It was recommended that the Clerk would write to Wakefield District Council to advise of the public footbridge condition and to gain knowledge of responsible person to rectify.
