- 86.1 It was RESOLVED that the report was RECEIVED with no recommendations from the external auditor.

- **87.1** A discussion took place, Cllr Bell called point to order 7b that the action plan with the recommendations had been recommended by the F&GP committee under agenda item 84.2 and therefore conflicted with any decision on further similar action on this agenda item.

It was **RESOLVED** that the Clerk would raise the agenda conflict between the internal auditor's report recommendations and the required action plan for clarity on how to process through the Council agenda items.

It was also NOTED that further information on the recommendations would be sought relating to banking access.

- 88. To receive an update on Low Ackworth Playing Fields Lease progression.
- **88.1** A verbal update was provided by the Clerk advising of progress made within the last month and that the lease was once again back with Wakefield District Council. It was **RESOLVED** that the update had been **RECEIVED**.
- 89. To receive correspondence from a resident regarding the exercise equipment on Dando Way, requesting for Council to consider the installation of additional children's play equipment and to decide a course of action.
- 89.1 A discussion took place.

It was **RESOLVED** that the item would be **DEFERRED** to the next meeting of the Village Amenities Committee for consideration of children's play equipment to be installed in a location on the Strata Estate as opposed to Dando Way.

- 90. To receive further update on expressions of interest received relating to the Neighbourhood Plan and decide a course of action.
- **90.1** Cllr Balfour **PROPOSED** that the Clerk writes to Wakefield District Council to seek a representative to host a meeting to information share about the requirements of implementing a Neighbourhood Plan and to outline the responsibilities of the Parish Council. Invitation to the meeting to be sent to the 14 residents who at the time of this meeting have expressed interest and Ackworth Parish Councillors. A report from the meeting to be added to a further full council meeting for further review. The proposal was seconded.

It was **RESOLVED** that the proposal was **APPROVED**.

- 91. To further review a request to consider support with a donation to Ackworth Senior Citizens Fund under section 137 grants for the Annual Christmas Tea.
- **91.1** A discussion took place.

£1500 was proposed by Cllr Richmond and Seconded – Later WITHDRAWN by both proposer and seconder £750 was proposed by Cllr A Sherratt and Seconded – Later WITHDRAWN by both proposer and seconder £1000 was proposed by Cllr S Sherratt and Seconded.

It was **RESOLVED** that under section 137 grants of the local government act 1972, a £1000 grant was **APPROVED** to be donated to Ackworth Senior Citizens to support the Annual Christmas Tea.

It was **NOTED** that an application form would be required.

- 92. To review and select lampposts for Christmas 2025 light wraps to be installed and consider resident communication.
- **92.1** It was **RESOLVED** that delegated authority would be given to the Clerk and Cllr Cook for the selection of the final 20 lampposts to be wrapped for Christmas 2025.

It was NOTED that the communication method to the residents within the Newsletter draft was accepted.

- 93. To receive a draft copy of the Autumn/Winter Newsletter for review and to consider approval of content.
- 93.1 A discussion took place.

It was **NOTED** that an agenda item would be added to the next Village Events and Communications Subcommittee meeting to review the frequency of the Newsletter, the option for an online newsletter and the accessibility of the current formatting.

It was **RESOLVED** that the received Newsletter was **APPROVED**.

- **94.1** To receive a proposal from Cllr Roberts to be given delegated authority by Council to progress the lease agreement of Low Ackworth playing fields, car park and play area which is currently under review between Wakefield District Council and Ackworth Parish as and where required in his capacity as both Chair to Ackworth Parish Council and Ward 1 District Councillor.
- **94.2** To receive a proposal from Cllr Maiden to supply Councillors with a term dated ID badge and lanyard to be identifiable when attending Council events.
- **94.3** To receive a proposal from Cllr A Sherratt that Ackworth Parish Council work with Low Ackworth Community Association, providing administrative support, to ensure that the existing building on Town End Playing Fields is removed as quickly as possible to make the site safe for all residents, removing the risk of further vandalism and arson, whilst removing the unsightly structure.
- **94.4** To receive a proposal from Cllr Richmond that this council resolves that no new lease for Townend Playing Field shall be executed until an official copy of the previous lease agreement has been obtained and thoroughly reviewed. The Clerk is instructed to take all necessary steps to secure the document from the appropriate authority, including Wakefield Council and HM Land Registry if required.
- **94.1** The proposal was seconded. A discussion took place. It was **NOTED** that from the previous meeting District Councillors & WMDC support had already been approved. On this basis Cllr Roberts along with the seconder withdrew. It was **RESOLVED** that the motion was **WITHDRAWN**.
- 94.2 In the absence of Cllr Maiden, it was RESOLVED that the motion was DEFERRED.
- **94.3** It was **RESOLVED** that the motion was **APPROVED** for the Parish Council team to support Low Ackworth Community Centre Association in administration.

The Chair requested extension of the meeting under Standing Order 3W which was APPROVED.

94.4 A discussion took place. Cllr Balfour called a point to order to procedurally defer the motion. The Clerk requested confirmation of the Standing Order being applied. Cllr Balfour confirmed 1U. The Chair proceeded.

It was **RESOLVED** that the motion was **DEFERRED** to the next meeting pending Cllr Richmond circulating information read out to all Councillors during the meeting relating to statutory duties under local government act 1972 as requested by the Chair.
